


Summary of Mergers & Acquisitions in Mexico

of Transactions per Month



Annual Transactions (US\$ million)




Summary of Transactions Abroad by Mexican Companies

Disclosed Deal Volume by Mexican Companies Abroad


of Transactions per Month



Summary of Mergers & Acquisitions by Industry


The **real estate** industry led the domestic M&A activity in Mexico, with **4 announced transactions** in January 2025, which represents **26.7%** of the total announced transactions.
