


Summary of Mergers & Acquisitions in Colombia

In October 2024, **6 transactions** were announced in Colombia, decreasing by **3 transaction** versus the previous month. Compared to the previous month last year, the total volume of transactions decreased by **4 transactions**.

Disclosed Deal Volume and Value of Acquisitions in ColombiaAnnual Transactions (US\$ Million)






Disclosed Deal Volume by Colombian Companies Abroad


Disclosed Deal Volume and Value by Colombian Companies Abroad Annual Transactions (US\$ Million)


